

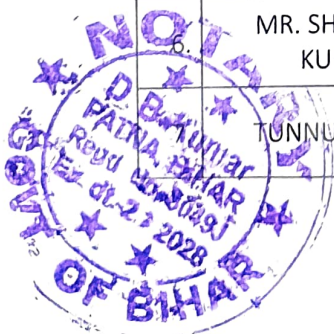
## Affidavit
